Larimer County Horseman's Association (LCHA) meetings are always on the first Monday of every month. Right?



of having several kinds of fun at once – riding, poker, friends, and possibly winning prizes.

***The Poker Ride – a high point in our summer – is the main fund raising event of the year for the Larimer County Horseman's Association (LCHA).***

The object of this ride is to have FUN, and possibly win some prizes! After a leisurely ride through Lory State Park, you can indulge in lunch with your friends and then see what prizes you may have won!

We know you will enjoy beautiful Lory State Park, a facility of the state of Colorado parks system. The basic ride will be about 5 to 6 miles and does not require a particularly fit horse. It will probably take about 2 to 2-1/2 hours at a walk on a moderately hilly trail to do the poker ride. We recommend you bring enough drinking water for the trail, and your lunch.

Riders follow a set course collecting a poker hand from different points.

The trail is well-marked. It includes several bridges. If your horse is tender-footed, it may need shoes or boots on the few areas that are moderately rocky. Most of the trail is packed earth, requiring no shoes.

Best hand wins the pot but there will also be several prizes for others and a prize drawing at the end of the day. You do not need to know how to play poker.

***Event Details***

Saturday, September 11

Lory State Park, Eltuck picnic area

\$25 per rider (you also need to buy a parking pass from the park for \$5)

The first riders leave by 10:30 A.M., and the last riders by 11:30 A.M. Please leave in intervals, only a few at a time, to help alleviate crowding on the trail and at the checkpoints.

Water for yourself and your horse

## Rules of the Ride

- A helmet is REQUIRED if you are under age 18, and all minors must ride with an adult sponsor.
- Juniors may not ride stallions.
- Required: Place a yellow ribbon in your horse's tail AND ON THE BRIDLE if you are riding a stallion.
- No unriden horses
- Required: Place a red ribbon in your horse's tail if your horse tends to kick. Please also give verbal warnings to riders behind that are riding too close.
- Optional and Recommended: Place a green ribbon in your horse's tail if you and/or your horse are inexperienced. Please pair up with experienced horse and rider for the duration of the ride if you are inexperienced.
- Please keep at least a horse length between you and the next horse, especially on the single track hills!
- If you feel you need to pass the horse in front of you, ask for permission and proceed at a walk only.
- Be courteous to hikers, bicyclists, equestrians, and volunteers. Management reserves the right to dismiss anyone from the ride activities at this ride and future rides for lack of consideration for others.
- Do not canter or gallop up hills. This may upset other horses and create an unsafe situation.
- Take care of your horse right after the ride before you go to the lunch area. Be sure to let them drink after the ride.
- Be prepared to tie your horse to a horse trailer (your own or with owner's permission), or return your horse to your local stable if applicable before lunch/prize activities.
- Horses are not allowed in the lunch area.

## Study Explores How Horses View the World

On the trail, in the dressage arena, at the racetrack, on the cross-country train--wherever horses may be, we've all seen it: the "Spook"-- that sudden, bolting reaction of shock so particular to our equine friends. It might be because some animal runs up, or some object is blown in by the wind, taking the horse by surprise. But sometimes it's just something you're sure they've seen many times before--so why spook about it now? New research at the Aptos, California-based Equine Research Foundation (ERF) now has answers to that question.

According to Evelyn B. Hanggi, MS, PhD, co-director of the ERF, one theory about spooking is that objects appear different to horses when viewed from various angles. Hence, a mailbox, a sign, or a pile of bars could take on new characteristics when viewed from another side. "What we wanted to know was whether the horses could understand that the parts equal the whole," she said.

Hanggi believed they could. "If not, they would spend much of their time spooking and running away from everything," she said.

To test her theory, she established an experiment in which horses were trained through positive reinforcement to select one of two toys: a lizard rather than a dinosaur; a mower instead of a wheelbarrow; and a tractor instead of a truck. Initially these objects were always placed in the same position. But once the horses were well-trained, Hanggi started rotating the objects to see if they could still identify the "correct" choice. Positions included backward, sideways, and upside-down.

The results indicated that, overall, the horses immediately recognized the objects from many novel viewpoints, although results varied from one horse to another, and some rotations were more difficult to recognize than others, Hanggi said. Specifically, they performed best when the objects were upright instead of upside down.

"This suggests that the horses were using specific, familiar features that they learned initially in the training, when making their decisions," said Hanggi. "Their ability to perform correctly appears to be crucially linked to being allowed to observe and learn about the objects first."

The results suggest that horses that are allowed to look around and discover, whether under saddle or at rest, will be more apt to recognize objects from different angles later and might be less likely to react adversely to them, she said.

Prior ERF research has already disproved another possible explanation for spooking: the theory that horses do not recognize objects with one eye that they had previously seen earlier with the other eye only, Hanggi said.

## Ride Limitations

Some LCHA trail rides have been large. When large numbers of people sign up for trial rides, the ride leader may take one or more of the following actions:

- Encourage horse pooling (if parking space is an issue)
- Limit the number of riders (if this happens, the ride leader will take people on a first come, first served basis, and then will create a waiting list and call people on the waiting list if someone else cancels)
- Depending on the nature of the trail and the experience level of the horse and rider, the ride leader may suggest that some riders not attend a specific ride.

All trail ride sign-ups are strictly on a first-come, first served basis.

## Insurance Concerns

The LCHA Board of Directors discovered that our insurance company has been charging an additional fee for each event we sponsor in which non-members can participate. In Board discussions, we decided that we need to keep many of our events open to the public, but we also need to keep some events for members only to limit our insurance costs. 
