Minutes from the Previous Executive Board Meeting were reviewed. President Crosby made the correction that the meeting was not a full board meeting. Stated that in the future it will be referred to as an Executive Board Work Shop.

Ken Stevens made a motion to accept the minutes, second by Glen Ansley. Motion passed unanimously.

Presidents Report:

Had a sit down with Tom Clutch of the Adams Mark Hotel. Tom stated that he was unable to come up with the original contract, so he requested the contract be renegotiated. The contract now calls for 60 rooms/night 220 total rooms. Meeting rooms will be one big room and six breakout rooms. Dale was also told that the mezzanine could be used for a family event if needed.

Dates for the 2003 F.D.O.A. Training Seminar (formally know as FDOA Conference) will be July 7^{th} - 11^{th} , 2003. Board members coming to set up for the Training Seminar can arrive on July 5^{th} or 6^{th} 2003. Room block will run from the 5^{th} – 13^{th} . The room rate will be \$89.00/night.

Dale said that if we have any ideas for potential trainers, to please make a list of those people, any contact information we have, and forward it to Roxanne.

A comment was made that bi-laws said the yearly training would be known as the F.D.O.A. Conference. Glen Ansley made a motion that the bi-laws be changed where the conference was concerned so that it would be known as the F.D.O.A. Training Seminar. Dale Crosby seconded the motion. Motion passed with all in favor none opposed.

Dale said that Amy has the newsletters ready to go and at the printers. He advised that there was no information in the newsletter about the upcoming training seminar. He stated that he did not want to delay the newsletter or over burden it, so he told Amy to go ahead and get out. DOE Grant

I have received the final paper work for the Grant from the Department of Education of Education for \$55,000. Dennis Bowers met with me and we completed a Financial Review for the previous year. I will be submitting a budget with the application within the next two weeks and anticipate disbursement of funds shortly thereafter. The funds will be disbursed in a lump sum payment. I advised Dale Crosby that I would need a letter authorizing me to sign applications and submit paperwork as well as administer the grant. Dale has signed that letter.

I will be submitting a letter to Sheriff Kevin Beary officially requesting their involvement. The involvement that I have requested is:

- b) Inviting and providing services to VIP's that attend as in the Sheriff, local chiefs, the Governor, etc.
- c) Arranging ground transportation to and from airport for speakers and similar duties

- f) Prepare goodie bags
- g) Assist with record keeping
- h) Such other duties as may be agreed upon in the future
- i) Provide info to attendees and coordinate any special packages or events Lt. Helgren states that she believes that these services would be beneficial and believes the Sheriff will probably approve the request. She does request that the Conference Fees and Membership Fees be waived for those directly involved in the event. She also request that since she would be assigning persons to be on site from early morning to late evening that some form of muster room be provided where persons can take a break at appropriate times.

President Crosby attended the DARE America update for the new curriculum. Target date for release of the new middle school, or elementary, or both are September 2003. Said that they received a definite MAYBE that the middle school curriculum will be out in 2003.

The main curriculum will be the Middle School Curriculum with the Elementary and High School curriculums working off of that.

All curriculums will use the facilitation method. Now the DARE Officer will go from being "The Sage on the stage to the Guide on the side".

Once implemented the new DARE Officer Training will certify the officer in all curriculums, Elementary, Middle, High School, and will also make the officer a Certified School Resource Officer.

Attended a state conference workshop and was told that state conferences would be required to provide facilitation training, 3 hrs on the new elementary school curriculum, and 3 hrs on the new middle school curriculum.

No information was available on the cost or availability of the new workbooks. It is hoped that the cost will remain about the same.

There was a question as to weather DARE qualified for the Drug Free and Safe Schools Money. DARE does qualify for those funds. There is a letter on the DARE WEB sight that clarifies any misunderstandings and can be used to show DARE does qualify.

DARE Web sight got hacked over the summer. During the repair of the sight additional security measures were added. As a result of the rework some subscribers were accidentally dropped from the system. If you have not received a bulletin in the last 30 days you should sign up again.

Motion was make by Ken Stevens for the Full Board to allow the Exec. Board to make the Decision about the upcoming conference rate. Motion seconded by Nestor Figueroa. All approved motion.

Motion made by Roxanne Whiddon to approve funding for travel and perdiem for President and Board Member to necessary meetings. Motion seconded by Cecil Elkins. Motion approved by all.
