

# Campership Application for Howard H. Cherry Summer Camp Programs

The goal of the Hawkeye Area Council and the Council Camping Committee is for every Scout to be able to participate in a long-term summer camp experience. Our Campership Program is designed to help Scouts, in need of financial assistance, attend the Howard H. Cherry Scout Reservation. A limited number of camperships are available for Scouts who cannot otherwise afford to attend camp.

Camperships are subject to the following conditions:

- The Scout should pay as much as possible.
- The troop or chartered partner organization should pay as much as possible.
- The troop should provide money-earning opportunities (popcorn sales, etc.) for Scouts to help them earn their own way.
- Scoutmasters should apply only for the balance needed after the above sources are exhausted. Camperships will be issued for a maximum of half the camp fee.
- The application deadline for camperships is **May 1**. If a Webelos Scout is joining a troop after the deadline, we request that camperships be discussed with his family before he transfers so paperwork can be submitted by **May 1**.
- **Applications must be filled out completely. Side one is completed by the parent/guardian. Side two is completed by the unit leader and unit committee. All requested signatures are required for campership applications to be processed. Incomplete forms will be returned.**
- **Each Scout applying for a campership should use a separate form.**
