**Meeting Host**: <u>Yuri Arajs</u>, curator of the Outsiders & Others Gallery (612-338-3435, <u>www.outsidersandothers.org</u>) talked briefly about his current "Lawyers as Artists" exhibit running until Nov. 8, about the next exhibit, "Strictly Women," opening Nov. 15, and another exhibit, "Playthings," featuring found objects, opening Nov. 22 in the Uptown area. Artists can submit work samples at any time for consideration in his future shows. Submit up to eight images, an artistic resume and artist statement (to tell briefly about your work) so Yuri can see if it fits into the mission of his gallery or the theme of a future show. #### **Discussion**:

\* <u>Joy Purchase</u> facilitated a discussion of the Support, Mentoring and Promotion areas of potential focus / services which a group of artists worked on July 15th.

#### 1. **SUPPORT**: established through

\* Support groups / types to be determined by demand – such as artists who experience depression and how they can work through blocks; dealing with isolation; highlighting successes and challenges; these could be addressed through a co-counseling process with a timer to assure that everyone can participate; <u>Tara Innmon</u> and <u>Lynn Schwartz</u> agreed to work on a format or structure for the November meeting.

\* Critiques / facilitated by members for members – <u>Laurie McKiernan</u> has a method to critique involving emotional/technical response; this gives the artist more control to say what they want in terms of critiquing. She will further explain and help teach this method. Critiques and involvement of other artists would help artists to see their art objectively and further improve their art. A challenge would be to format meetings to create an environment of constructive, supportive critiques. Co-facilitators at meetings could provide back-up and resource assistance.

\* Resource information – such as where to find studios, rehearsal spaces, professional development workshops, advice on resumes, work samples, portfolios, grant-writing, auditioning, how to market books/articles/plays, etc., how to get one's work into the community, obtain video equipment to record performances (<u>Chris Osgood</u> at Springboard for the Arts), helpful web site addresses (such as for Jaws Software to make meeting notes accessible to members who are blind or of low vision), etc.

\* Trading skills

### 2. MENTORSHIP: established through

\* Workshops / facilitated by members for members

Types of workshops to be determined by demand; can include but not be limited to:

+ Techniques in mediums

+ Grant writing – this could be a separate meeting

+ Resume building

+ Artist statements

+ Dealing with disappointments (slow sales), denials (of grants), etc.

+ How to prepare for auditions, how to get into a show, etc.

+ How to promote yourself, your art, your show – perhaps taught by Dean Seal or by visual artists who have had success in preparing effective brochures, websites, etc.

+ Develop business skills to get an artist's work out into the community

+ How to get donated space for workshops, exhibits, performances, etc.

+ How to structure a workshop

+ "Threshold Of Earnings Seminar" to show how not to lose Social Security Insurance/ SSDI benefits if arts income exceeds specified level. (Jim Czechowicz of the SSA has offered to present at one of our future meetings.)

+ Audience Building – "the list" of people you want to reach via mail or e-mail People who give workshops can then add these experiences to their resumes.

<u>Joy Purchase</u> will create an outline for how to submit a workshop plan or proposal – where it would be done, size of class, estimated costs and supplies, etc.

+ Advocacy - perhaps led by Rachel Parker, an advocate at PACER Center

## 3. **PROMOTION**: established through

- \* Creating a web site / billboard how to develop an accessible website (Jaws can read it)
- \* Community projects
- \* Creating group venues
- \* Creating a larger annual festival of arts for artwork by artist with disability labels.

## 4. PUBLIC AWARENESS: established by

- \* Creating a presence through artistic expression.
- \* Promoting the work of artists with disability labels.
- \* Political Activism / dictated by individual interests.
