From TCVESSA's President: Courtney Hansen

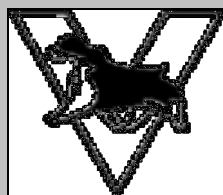
Hi All,

Specialty Discussion

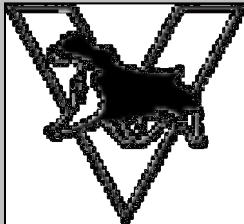
Friday set up will begin at 1:00 with exhibitors having access to the building at 2:00.

Roll Call and Welcome – 7:36 pm

Secretary's Report

We delayed approval of the prior meeting minutes until next the meeting. We had the second and final reading for Linda and Kevin Krueger. Liz moved, BA second – all in favor. Motion to approve their membership carries.

Treasurer's Report

We have \$4524.40 in our account– all bills paid from the Specialty. We lost slightly over \$4900 at Specialty which has been our typical loss for the last several year. We did gain \$1965.83 from the last agility trial.

Old Business

The Minneapolis KC (Jordan) was fun but not necessarily a great venue for a Specialty. Outdoor shows in Minnesota are a challenge! General consensus was that we should do it again as a Supported Entry if that option exists.

New Business

Given the high cost of the Specialty, we discussed if Cloud 9 for would be an option for future trials since the daily charge is lower? How much cleaning would we have to do? Many questions would have to be answered: Difference in cost between the two facilities? Power and grooming space? Room for both Obedience and Rally ring? .

We want to consider an All-Breed Obedience and Rally Trial in 2020 to help defray the cost of the show. We need to explore what the logistics would be and any AKC requirements. We would “honor” Springers with some sort of award. As an All-Breed Trial, we would offer one obedience and one rally trial each day. Liz to follow up with AKC on what it would take to make ours an All-Breed show.

Liz requested potential judge candidates for 2020 with an eye towards less expensive/ local options.

2021 Specialty – There will be a significant challenge with our date as the National Specialty will be held on Michigan the week prior. We should consider options such as keeping our Obedience/Rally trial on that weekend and/or potentially having a supported entry or Specialty another weekend. Potentially partner with another club – WESSA or even prior to the National.

Kathy requested that we move our Agility trial from OTR to Cloud 9 – June, December and January at Cloud 9. October at OTR. OTR could not have a competing AKC trial on those same weekends. Jan Richards (trial secretary) is retiring in January so Kathy is interviewing new potential secretaries.

The Board approved the hiring of Mike Teh for all four trials in 2020.

Kathy suggested we give Lynn Hicks a gas card for \$40 dollars to thank her for helping after the Agility Trial. Liz moved, BA seconded. All in favor.

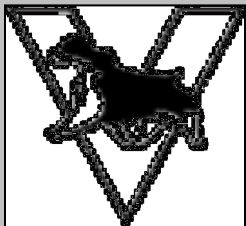

Approval of the Minutes – Liz moved and Diane seconded; the minutes were approved.

There were no new applications for membership.

Treasurer's Report

We have \$4347.83 in the treasury. Kathy requested two checks, \$250 each made out to Cloud 9 for the two trials (January 2020 and May 2020). One advantage to Cloud 9 is that the club is not required to reset the courses at the end of the trial.

At our prior meeting, we discussed a number of question regarding Cloud 9 as a option for future Specialties. Unfortunately, Cloud 9 does not have electrical that would allow us to have our Specialty in that location.

Kathy moved that the club issue the two checks and Tekla seconded. The motion carried.

Specialty Updates

We might be able to cut down to two days of rental for the Obedience trial in 2021. If we go in that direction, we should proactively ask to reserve OTR in 2022.

Judges for Conformation and Sweeps

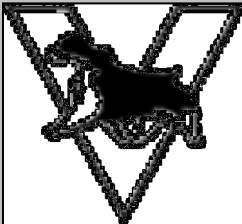
We discussed options for both the regular and sweeps classes for the 2020 Specialty. The board agreed on two priority judges for each and Liz will contact them regarding availability.

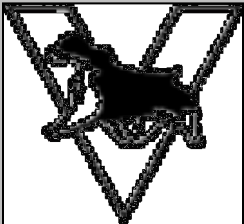
Courtney will send out information on the State Fair in case anyone wants to volunteer.

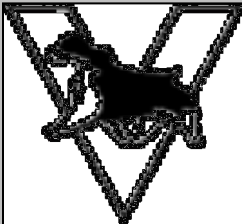

Upcoming Agility Trial – Kathy hired a caterer (egg roll) for the Friday trial to bring some variety to the meals we provide for workers.

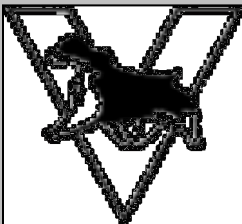
FAST CAT – Kathy suggested we look into doing FAST CAT as a fund raiser for the club. She has reached out someone who runs these trials (All Breed trial).

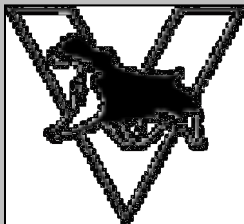

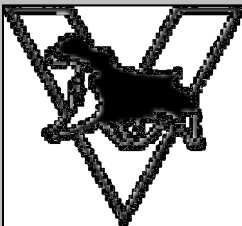

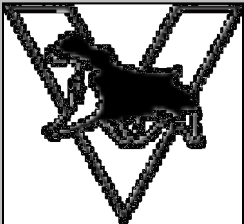

When working on the neck, using the noose around the muzzle helps keep the dog still and gives you room to work.

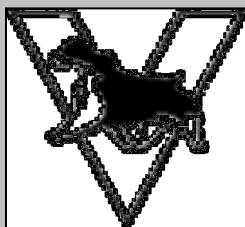
Never brush a dry coat!

A mirror is really helpful when working on the underline.

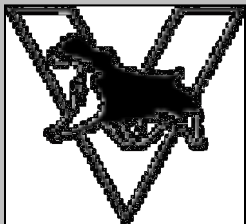
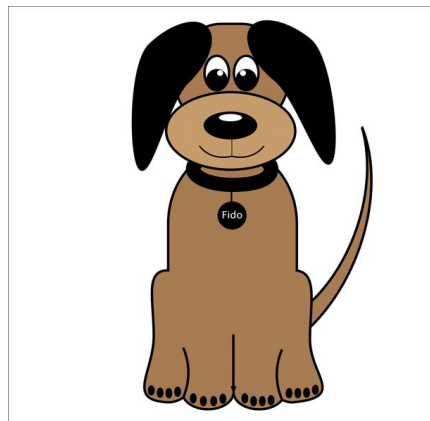
