Additionally, I understand that there are also risks associtively with dive travel, including, but not limited to the possible injury or loss of life as a result of a dive boat accident, as well ravel to and from dive sites. Despite the potential hazards and dangers associated with the activity of diving, I wish to seed and I freely accept and expressly assume all risk, dangers and hazards that may arise from diving activities which lid result in personal injury, loss of life and property damage to me.
