RE: Request to cease use of "WIEG's Energy Ratepayer's Bill of Rights"

Dear Ms. Ceylor:

We write as legal counsel to the Wisconsin Industrial Energy Group, Inc. (WIEG).

WIEG's Board of Directors is aware that the work entitled "WIEG's Energy Ratepayers' Bill of Rights" (RBOR) has been used and promoted by Save Our Unique Lands (SOUL), particularly via SOUL's website.

WIEG's Energy Ratepayers' Bill of Rights was prepared on behalf of and for WIEG, in part, by Nino Amato in connection with his duties as WIEG President. The Consulting Agreement between Mr. Amato and WIEG grants WIEG ownership in all work prepared or created by him, including the copyright in such work.

As the copyright owner, WIEG has the exclusive right to reproduce, distribute, and prepare derivative works based on the "WIEG's Energy Ratepayers' Bill of Rights." *See* 17 U.S.C. §106. The unauthorized reproduction and distribution of this work, including by display on the internet, infringes WIEG's copyright. *See* 17 U.S.C. §501.

WIEG has requested Mr. Amato to cease the use of the RPBOR by him and others. In response, he has informed us that SOUL's use and promotion of the RPBOR was done on its own and without his recommendation or authorization.

Accordingly, WIEG requests that you and SOUL take steps immediately to cease using -for yourself, for SOUL, or for any other organization -- the work entitled "WIEG's Energy
Ratepayers' Bill of Rights" and, specifically, that you cause it to be removed from any website
on which it appears including, but not limited to, the SOUL website where it can be found at
